April 1, 2024

Marklesburg Borough Council regular monthly meeting was held at the Borough Building on Monday, April 1, 2024, at 6:30 p.m. Present were council members: Ashley Hicks, Cathy Failor, Brian Sheaffer, Brian Hunsicker, Aaron Beaver and Wendi Hunsicker along with and Secretary Mary Lou Showalter. Public present: Marlin Hunsicker.

President Ashley Hicks declared a quorum present and Brian Hunsicker offered an invocation followed by the Pledge of Allegiance.

Minutes of the March meeting were reviewed and were approved on a motion by Brian Hunsicker, seconded by Brain Sheaffer.

Treasurer's report: General Fund Checking \$35,106.63; MMA \$71,710.50; 24 month CD \$26,599.78, State Fund Checking \$25,563.17 and MMA \$29,392.59. Mary Lou indicated that the annual audit was completed on 3/18/24 and all was found to be in order. Treasurer's report was approved pending audit on a motion by Brian Sheaffer, seconded by Cathy Failor.

Volunteer fire fighters/EMS must respond to 50% of fire and ambulance calls and Volunteers for kitchen help, fund raisers and administration must attend 70% of events. We will check with the other townships served by the MVC to see if any interest there. We can schedule a meeting with them. Mary Lou will type up the ordinance for Marklesburg Borough to have for May Meeting.
